



- Cash rebate of \$4.00 (ex GST) for every carton of Lion beer, cider hard seltzer and RTD purchased\*
- Cash rebate of \$25.00 (ex GST) for every Lion keg purchased\*
- Ability to host home finals should your club qualify

\* Applies to clubs who do not have an existing sponsorship or pourage rights deal with Lion. Clubs with a separate agreement will be entitled to rebates according to their individual deal.

## What Does Your Club need to do on Adelaide Footy League Match Days to be Compliant?

- If you serve tap beer, exclusively range Lion beers on tap
- Range a maximum of 2 non-Lion packaged beer brands which are positioned on lower shelves of your fridges, with the remaining packaged beers being Lion brands
- If you range cider, range a minimum of 1 Lion cider brand
- If you range hard seltzer, range a minimum of 1 Lion hard seltzer brand
- Ensure that your venue achieves the above asks by Friday 31<sup>st</sup> May
- If you purchase through a retailer, retain your Lion purchase receipts or statement of account
- Submit the Lion Volume Rebate Claim form to your Lion Sales Executive when you wish to claim your rebates, along with copies of proof of purchase documents

- In order to be allocated home finals, clubs must:
  - Achieve all compliance asks detailed above and verify compliance by 31<sup>st</sup> May via visit from your Lion Sales Executive, or sending through photos of compliant fridges & taps
  - Should a club who has not been confirmed as compliant prior to the deadline finish in a ladder position which would earn a home final and still wishes to host home finals, the club will pay a Cash Compensation Fee of \$2,000 ex GST to Lion

Your Lion Sales Executive will arrange a meeting to partner you with the above, and then again to confirm compliance ahead of 31<sup>st</sup> May. ## **Compliant Fridge Example**

This fridge layout is compliant to Lion's proposed sponsorship deal as it:

- Has only 2 x non-Lion beer products (highlighted in orange)
- Has all non-Lion products on the lower non-preferred shelves.



## Non-Compliant Fridge Example

This fridge layout is *not compliant* to Lion's proposed sponsorship deal as it:

- Has more than 2 x non-Lion beer product (highlighted in orange)
- Please note that each individual Coopers product counts as 1 x non-Lion brand



## Non-Compliant Fridge Example

This fridge layout is *not compliant* to Lion's proposed sponsorship deal as it:

- Has non-Lion beer products on higher, preferred shelves (highlighted in orange)
- Non-Lion product would need to be moved to lower, non-preferred shelf to achieve compliance
